AUDITOR ROGER REYNOLDS HOLDING TOWN HALL MEETINGS ACROSS BUTLER COUNTY

Reappraisal of Property Values Will be Topic; Informal Meetings Will Also be Held

HAMILTON, OHIO – Auditor Roger Reynolds will hold Town Hall-style evening meetings around Butler County in September and October. Locations, dates and times are listed at the bottom of this release. The public is encouraged to attend. In addition, informal one-on-one meetings with Auditor’s Office staff will be held on different dates and those are also listed at the bottom of this release.

A mailer that gives specific information about home values was sent this week and should be arriving in homes over the next few days.

The main subject of the meetings will be this year’s property reappraisal. Every six years, the state of Ohio mandates that the Auditor’s Office conduct a reappraisal of property within the county. The reappraisal process was recently completed for 2008.

“Our office strives to be as accessible as possible and we are going to be diligent in taking this reappraisal information directly to the residents of Butler County,” stated Reynolds. “The public has a right to meet their elected officials and their respected office staffs, and to voice any questions or thoughts directly to their local government. This reappraisal will rightfully garner interest within the county, and we want to bring clarity and insight to both the process and the results.”
